

# CERTIFICATE OF LIABILITY INSURANCE

The City of Penticton (171 Main St. Penticton BC, V2A 5A9) AND Global Spectrum Management LP ( 273 Power St. Penticton BC V2A 7K9) requires all exhibitors at the BC Fire Expo to provide proof of insurance coverage and therefore we need to obtain Certificates of Insurance (COI) from all vendors exhibiting at the BC Fire Expo. To protect yourself, other exhibitors, visitors and show organizers, you must have adequate Liability Insurance with a **minimum \$5,000,000** limit.

Please note the Certificate of Insurance should provide for 30-days notice to us in the event of policy cancellation, non-renewal or material change. If you have questions regarding this request feel to contact Christine at 1-604-492-3080. **The FCABC's insurance policy does not extend coverage to any exhibits and requires you to submit a Certificate of Insurance no later than 30 days prior to opening of the BC Fire Expo and no later than May 2, 2019.**

Please have your insurance company prepare a Certificate of Insurance which must list the **Fire Chiefs' Association of BC, the City of Penticton (171 Main St. Penticton BC, V2A 5A9) AND Global Spectrum Management LP ( 273 Power St. Penticton BC V2A 7K9), as additional named insured, only with the respect to the acts or omissions or Fire Chiefs' Association of BC, its agents, employees, representatives or contractors.**

- General Liability including bodily injury, property damage, non owned automobile liability and Products and Completed Operation with a limit of \$5M (or \$2M if approval given by the FCABC) per Occurrence.

- Limits of liability: Bodily injury & Property Damage – Each Occurrence \$5,000,000  
(Policy may be subject to a General Aggregate or Other aggregate – if so, please indicate on certificate)
